The profile of the transportation services required by the ECB typically covers the transportation of high-ranking persons (VIPs) — representatives of the ECB or external visitors. The requested services will generally be provided within the vicinity of the Frankfurt area: the regular transfers are between the different ECB premises, the ECB premises and hotels as well as to/from Frankfurt Airport (i.a.
