Honourable President of the European Parliament, dear Mr Tajani,

I am pleased to inform you that the ECB's Annual Report 2017 will be published in 22 official EU languages on the ECB's website at 15:00 CET on Monday, 9 April 2018.

The ECB's Annual Report, which is prepared in accordance with Article 284 of the Treaty on the Functioning of the European Union and Article 15 of the Statute of the European System of Central Banks and of the European Central Bank, will also be submitted to the Council of the European Union, the European Commission and the European Council.

The report covers the ECB's monetary policy, as well as economic and financial developments in 2017. It also presents the activities of the Eurosystem in its various areas of competence in the year under review.

The electronic advance version of this year's Annual Report in English, which is attached to this letter, is made available to you and to members of the European Parliament's Committee on Economic and Monetary Affairs under embargo.

In line with the practice that we adopted in 2016 in response to a suggestion from the European Parliament,<sup>1</sup> the ECB will publish, alongside the Annual Report 2017, its response to the points made by
