

# Market-specific information relevant to the mobilisation of marketable assets and DECCs

## Background

In order to mobilise marketable assets and DECCs as collateral, counterparties must include the following information in their mobilisation instructions<sup>1</sup>:

- the identifier of the counterparty mobilising the asset.
- the instructing party, i.e. the party sending the instruction.
- the reference of the instruction (which must be unique) as given by the instructing party.
- the instruction type – receive (RECE) in the case of a mobilisation<sup>2</sup>.
- the trade date of the instruction.
- the intended settlement date of the instruction.
- the ISIN identifying the marketable asset or DECC to be mobilised.
- the quantity and the quantity type (face amount) of the asset to be mobilised.
- the identifier of the counterparty asset account<sup>3</sup> which shall be used for the safekeeping of the asset.
- the type of legal instrument (pledge or repo) which shall be used for the mobilisation of the asset.
- the delivering party.
- the receiving CSD, i.e. the CSD operating the SSS where the asset shall be held after mobilisation.
- the delivering CSD, i.e. the CSD operating the SSS where the asset is held by the counterparty prior to mobilisation.

## Market-specific information

Table 1 provides an overview of the complementary market-specific information relevant to the mobilisation of marketable assets and DECCs, including:

- *NCB BIC* – NCB BIC to which mobilisation instructions should be sent<sup>4</sup>.
- *Receiving CSD* – name of the receiving CSD.
- *Receiving CSD BIC* – CSD BIC to which settlement instructions should be sent.
- *Receiving Account* – the CSD account where the asset shall be held upon mobilisation (which may differ depending on the location of the counterparty delivering the collateral or the collateralisation arrangement used i.e. repo or pledge).

<sup>1</sup> Mobilisation instructions are sent to the HCB. A corresponding settlement instruction is sent to the relevant CSD.

<sup>2</sup> The instruction type 'Deliver (DELI)' should be specified in the corresponding settlement instruction sent to the CSD.

<sup>3</sup> The Counterparty Asset Account is included in mobilisation instructions sent to the HCB. For settlement instructions sent to the CSD, the relevant Receiving Account listed in Table 1 is used.

<sup>4</sup> Mobilisation instructions are always be sent to the HCB irrespective of the mobilisation channel used.

- *Delivering Account Required?* – specifies whether the securities account of the delivering party must be populated in the instruction.
- *Party 2 Details Required?* – specifies whether the BIC of Party 2 (i.e. the Client of the CSD Participant) must be populated in the instruction.
- *Other Market Specific Elements?* – where relevant, specifies any other market-specific requirements relevant to the mobilisation of marketable assets and DECCs (for example, if different information needs to be provided depending on the type of asset being mobilised).
