## Reason for change / expected benefits / business case:

The currency is a search criterion in the A2A query of standing and predefined liquidity transfer orders that are stored as static data (camt.069 - Get Standing Order).

However, the T2S GUI screen related to the static data set-up of pre-defined and standing liquidity transfer (i.e. "Standing/Predefined Liquidity Transfer Order – New/Edit screen") does not include the currency field as an input criterion since this is implicit in the T2S Dedicated Cash Account. Since the same screen layout is used for querying these Standing/Predefined Liquidity Transfer Orders, the query screen (i.e. "Standing/Predefined Liquidity Transfer Orders, the query screen (i.e. "Standing/Predefined Liquidity Transfer Orders, the query screen (i.e. "Standing/Predefined Liquidity Transfer Orders - Search/List Screen") does not include the currency field either.

In any case, the currency is a search criterion in the A2A/U2A queries of settled liquidity transfers.

## **Description of Request:**

This change request removes the currency as a search criterion in the query screen of pre-defined and standing liquidity transfer orders.




# Query Liquidity Transfer Orders

The Query Liquidity Transfer Orders function shall provide the facility to query all the predefined and standing liquidity transfer orders set up in T2S. This function must allow the user to query static data (e.g., NCB / system entity, payment/settlement bank, T2S dedicated cash account, currency) and lists of valid value for all other search criteria. It must perform validations on the entered static data criteria and other selection criteria to ensure that the user has input valid values.
