Reason for change and expected benefits/business motivation:

With T2S CR480, the remaining to be settled quantity/amount in sese.024, camt.067 and semt.014 messages was adjusted to that in all cases the remaining to be settled quantity/amount is informed.

The same reporting approach should be applied to all cancellation request status advice messages, which might also report settlement quantities / amounts after a potential partial settlement attempt:

- sese.027 SecuritiesTransactionCancellationRequestStatusAdvice
- camt.075 IntraBalanceMovementCancellationRequestStatusAdvice

In this way, it will also be possible to derive from those messages whether a given cancellation was executed after a potential partial settlement.

Description of requested change:

T2S should report in all sese.027 / camt.075 messages the remaining to be settled quantity/amount in the settlement quantity/amount field respectively, whereby the following definitions should be applied:

- Remaining to be settled quantity = Originally instructed quantity settled quantity
- Remaining to be settled amount = Originally instructed amount for unmatched instructions; or
 Matched amount settled amount for matched instructions.

Similar rules for settlement quantity/amount fields in the camt.083 or semt.033 messages are not requested with this CR

Outcome/Decisions:

*CRG meeting of 9 July 2015: The CRG decided to put the Change Request on hold for the discussion in the September 2015 CRG meeting and agreed that the Change Request T2S-0533-SYS could be a potential candidate for fast-track Release 1.2.

* CRG meeting of 17-18 September 2015: The CRG agreed to put the Change Request on hold and agreed to include it in the list of Change Requests for Release 1.2. The CRG considered that the Change Request is not a showstopper for the migration of wave 3 participants.

* CRG teleconference of 1 October 2015: The CRG recommended to launch the detailed assessment on the Change Request.

Summary of functional, development, infrastructure and migration impacts

The impacts of this change request on the T2S domains/modules are the following:

LCMM:

Update of the LCMM function in charge of providing the settlement amount and settlement quantity in the messages related to the status advices:

- Update the calculations for the quantities for cancellations of Settlement instructions and settlement restrictions on securities (sese.027)

Request: T2S 0533 SYS

- Update the calculations for the amounts for cancellation of settlement instructions (sese.027) and cancellations on settlement restrictions on cash (camt.075)

Update of the related T2S use and T2S Mapping in order to clearly specify the reported quantity and amounts in case of cancellation instructions.

Query Management:

Not impacted since the CR only refers to sese.027 and camt.075. Nevertheless we would like to draw the attention to the fact, that the following query responses will show allegedly not consistent information in A2A (the relevant U2A screens do not contain quantity/amount fields):

- Cancellation Instruction Query Response for Intra-Balance Movements (camt.083): Field Settlement Amount will show the Original Settlement Amount
- Cancellation Instruction Query Response for Intra-Position Movements and Settlement Instructions (semt.033)
 - Field Settlement Quantity will show the Original Settlement Quantity
