Editorial changes regarding GFS v7.0, UDFS v4.0, UHB v4.0

Reason for change and expected benefits/business motivation:

The Editorial changes listed below are either related to GFS v7.0 or UDFS/UHB v4.0. Their incorporation into the GFS v7.0, UDFS or UHB v4.0 is required for clarifying the documentation underlying the software. Please note that the changes referring to UDFS v4.0 will also be reflected, when relevant, into the schema documentation published in MyStandards.

The Insolvency restriction type validation applies to the delivering securities account specified in a DELI/Debit instruction, as clearly stated in UDFS v4.0, 1.6.1.1.3 Validation process - Insolvency Restriction Type validation. However, the content of Table 9 – Restriction Matrix regarding RT case 4 is somehow misleading and should be clarified that part accordingly. The amendment is only required to align the UDFS.

Case 4 Rejection

T2S dedicated cash account

Restriction type code is IDCA. CB Rejection during the Business Validation application process of any Settlement Instruction debiting the restrict-ed T2S dedicated cash account. Their pro-cessing is definitely stopped. Settlement Instruction is rejected during the Business Validation application process if the Settlement Instruction debiting specifies the T2S dedicated cash account which has assigned an active insolvency restriction. Its processing is definitely stopped.
