#### Reason for change and expected benefits/business motivation:

In the area of access rights management, T2S provide the option to define secured groups that can be used to bundle certain types of reference data objects to simplify access rights management for object privileges.

However, in the current implementation, secured groups are only identified by a technical ID that T2S assigns to them when they are created. This makes it cumbersome to handle multiple secured groups in parallel, as they have no further description that allows to define for which purpose they are used (see example from UHB below).

#### This shall be adjusted:

• Two additional attributes shall be created for secured groups: NAME and DESCRIPTION.

These attributes will allow T2S Actors to provide more information on the purpose of a specific secured group. This will streamline the handling of secured groups and reduce operational risk.

#### **Description of requested change:**

Two additional attributes shall be created for Secured Groups:

- NAME: a short description of the secured group
- DESCRIPTION: a long description of the secured group

Those two new attributes NAME and DESCRIPTION shall have the following features:

- In the Secured Group New/Edit Screen, both attributes can be defined when creating new secured groups. It is also possible to update them when updating secured groups.
  - Both attributes are optional, i.e. each of them can be filled or it can be left empty.
- In the Secured Group Details Screen, both attributes are displayed
- In the Secured Group List Screen, at least the name shall be displayed within the search results

There is no need to ensure uniqueness of the names. This is left to the responsibility of the maintaining party.

- I The identifier of the secured group;
- I The type of the secured group, i.e. the type of the secured objects that can be assigned to the secured group.




